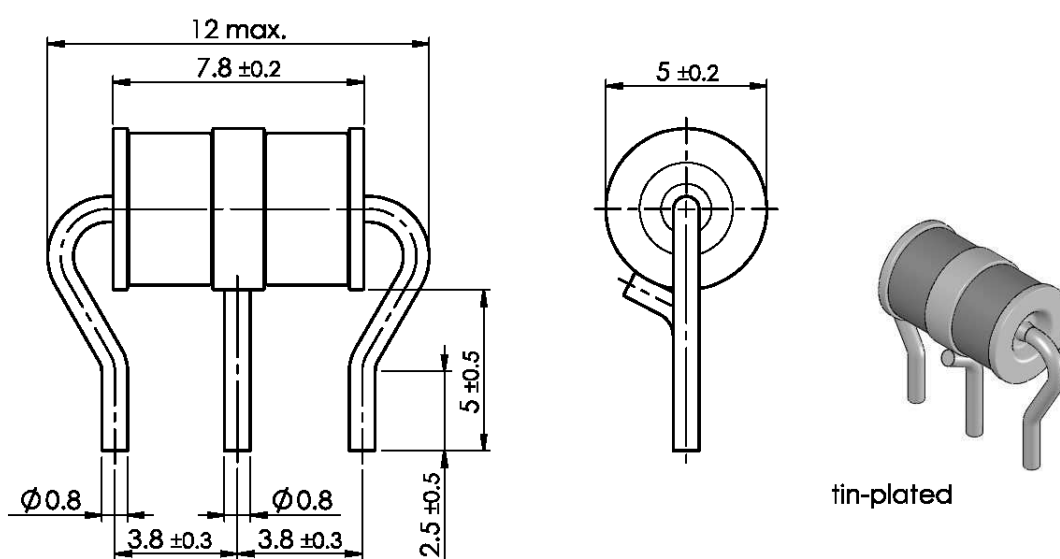
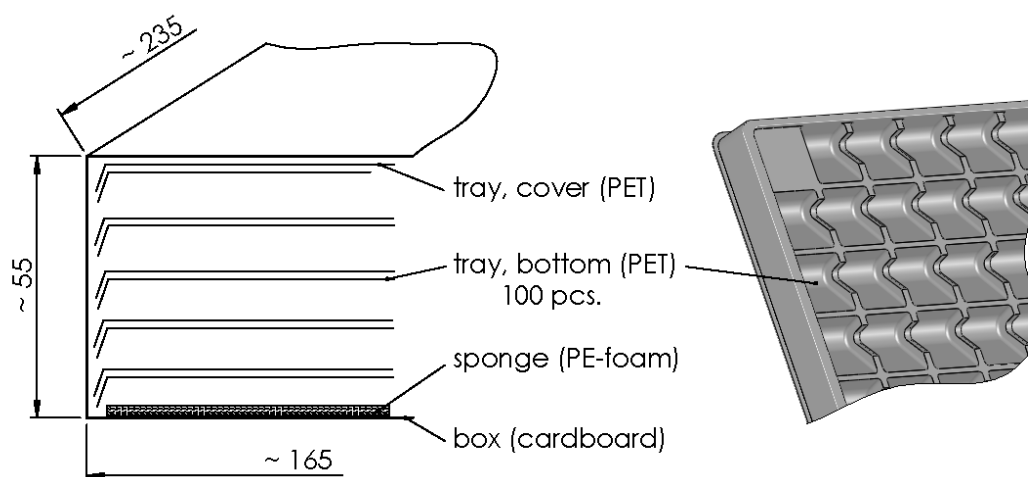

## Cautions and warnings
